1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc were not inspected or reported on.

Description	A detached dwelling house.
Accommodation	 Ground floor: entrance hallway, kitchen and dining, 2 bedrooms, bathroom, utility and a rear porch. First floor: landing, living room, 2 bedrooms (1 with walk in wardrobe) and a shower room.
Gross internal floor area (m ²)	173 sq m
Neighbourhood and location	The property is set on the edge of the town of Fort William in an area comprising of mixed housing, agricultural land and a holiday park.
	All essential services, amenities and transport links are nearby.
Age	Built in 2010.
Weather	Overcast with outbreaks of heavy rain. The preceding weather was seasonal.
Chimney stacks	Visually inspected with the aid of binoculars where appropriate None.
Roofing including roof space	Sloping roofs were visually inspected with the aid of binoculars where appropriate
	Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3 m ladder externally
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3 m ladder within the property
	If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so The roof is pitched and clad in a natural slate. The ridge is in a concrete tile. There are timber frame and clad dormer windows to the front with pitched and slated roofs. Flashings are in lead. There are Velux rooflights to the rear.
	Due to the nature of construction of the first floor, remaining roof spaces are limited. We viewed the upper apex via a ceiling hatch to the landing. The roof is constructed in factory manufactured timber roof trusses with a softwood sarking board. There is glass wool insulation between and over the ceiling joists. We viewed rigid insulation to the coombe.
Rainwater fittings	Visually inspected with the aid of binoculars where appropriate Upvc gutters and downpipes. The downpipes discharge to closed gullies.
Main walls	Visually inspected with the aid of binoculars where appropriate Foundations and concealed parts were not exposed or inspected External walls are in conventional modern timber frame cavity wall construction (2 walls with a narrow gap between). The outer wall is finished in a wet dash render on a concrete blockwork backing. There is smooth render to the base course. The internal wall is in timber and is structural and carries the weight of the first floor and roof. Internal surfaces are lined in plasterboard.

Electricity	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on Mains electricity supply. The meter and fuse board are located within the cupboard to the rear porch. Electrical fittings are of a modern pattern.
Gas	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on There is a Calor gas supply to the kitchen hob. The bottle and regulators are located to the rear.
Water, plumbing, bathroom	Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation
fittings	No tests whatsoever were carried out to the system or appliances Mains water supply. We suspect the incoming rising main is located in the kitchen. There is a stopcock below the sink. Plumbing supplies where viewed are in copper, wastes are in plastic.
	Bathroom fittings are modern and comprise of ceramic wcs, ceramic wash hand basins, an acrylic bath and proprietary shower enclosures. Surfaces within the showers and around the bath are in a proprietary wet wall. Showers are provided by thermostatic mixer valves.
Heating and hot water	Accessible parts of the system were visually inspected apart from communal systems, which were not inspected
	No tests whatsoever were carried out to the system or appliances Central heating is provided by an external oil fired condensing boiler which heats underfloor pipework to the ground floor and radiators to the first floor. The ground floor heating system is zone controlled. There is a separate programmer for the first floor radiators. The central heating was operating at the time of inspection. There is a plastic oil storage tank to the rear.
	Hot water is heated and stored in a direct fed stainless steel cylinder located within the airing cupboard to the first floor landing. The primary form of heating hot water is via the oil boiler.
Drainage	Drainage covers etc were not lifted Neither drains nor drainage systems were tested Drainage connects to a private septic tank to the front of the property.

alarms	No tests whatsoever were carried out to the system or appliances There are no fire or burglar alarms. There are smoke and heat detectors in various places.
	Fire Safety Legislation effective from February 2022 requires a smoke alarm to be installed in the room most frequently used for living purposes and in every circulation space on each floor. A heat detection alarm must be installed in every kitchen area and all smoke and heat alarms must be ceiling mounted and interlinked. Where there is a carbon fuelled appliance e.g. central heating boiler, open fire, wood burning stove, etc, a carbon monoxide detector is also required. The purchaser(s) should appraise themselves of the requirements of this legislation and engage with appropriate accredited contractors to ensure compliance.

4. Valuation and conveyancer issues

PART 1 - GENERAL

1.1 THE SURVEYORS

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. PART 2 - DESCRIPTION OF THE REPORT

2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

2.2 THE INSPECTION





The energy efficiency rating of your home

1 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). 2 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.
