1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.


Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc were not inspected or reported on.

Description	A detached bungalow.
Accommodation	Entrance hall, living and dining room, kitchen, sunroom, 3 bedrooms and a bathroom.

Neighbourhood and location	The property is set within the village of Spean Bridge in an area comprising of similar type properties There are reasonable facilities nearby which include a village shop, primary school and community facilities.
	All essential services, amenities and transport links are available within the regional centre town of Fort William, which is 10 miles from the subjects
Age	Built around the mid 1980s. The garage appears to have been added slightly later.
Weather	Overcast but dry. The preceding weather was mixed.
Chimney stacks	Visually inspected with the aid of binoculars where appropriate None.
Roofing including roof space	Sloping roofs were visually inspected with the aid of binoculars where appropriate
	Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3 m ladder externally
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3 m ladder within the property
	If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so
	The roof is pitched and covered in a concrete tile. The ridge is in a concrete tile. The hips are dressed in a upvc trim.
	Access to the roof space is via a ceiling hatch to the hall. The roof is constructed in timber fink trusses with a fibre board based sarking. There is glass wool between and over the ceiling joists.
Rainwater fittings	Visually inspected with the aid of binoculars where appropriate Upvc ogee gutters and plastic square downpipes. The downpipes discharge to grated gullies.

	Foundations and concealed parts were not exposed or inspected External walls are in timber frame cavity wall construction (2 walls with a narrow gap between). The outer wall is in a rendered concrete block. There is an area of reconstituted stone (Fyfe stone) to the front.
	The inner timber frame wall is structural and carries the weight of the roof. Internal surfaces are lined in plasterboard.

These appear to be more than 20 years of age. There is an older double glazed timber window to the sunroom. The external door is in timber. There is a sliding patio door to the sunroom. Fascias, soffits and bargeboards have been replaced or overclad in upvc.
External decorations	Visually inspected The front door and timber windows are stained. The rendered wall has been painted in part to the rear.

There is a timber window, timber personnel door and an up and over metal door. The rear part of the garage was later converted to create a sunroom to the main house.
Outside areas and boundaries	Visually inspected There are gardens mainly to the sides and rear. These are covered in a stone chip or grass. Ground to the rear is sloping and retained by a masonry wall. There are 2 garden sheds. There is off street car parking. Boundaries are in a mix of timber ranch style, rendered blockwork and post and wire.
Ceilings	Visually inspected from floor level Plasterboard lined throughout. There is coving in places.
Internal walls	Visually inspected from floor level Using a moisture meter, walls were randomly tested for dampness where considered appropriate Timber frame with plasterboard linings. The gable wall to the living room is lined in timber.
Floors including sub floors	Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1 m between the underside of floor joists and the solum as determined from the access hatch Floors to the main portion are in suspended timber (boarded joists). These were covered and carpeted at the time of inspection. The floor to the sunroom is in concrete. We did not inspect the sub floor space due to the lack of an obvious floor hatch.
Internal joinery and kitchen fittings	Built in cupboards were looked into but no stored items were moved Kitchen units were visually inspected excluding appliances Facings and skirtings are in timber. Internal doors are in flush panel. These appear original. Kitchen fittings comprise of a proprietary range of melamine/plastic faced base and wall units with a timber door, proprietary worktop and inset sink. There are spaces for the white goods. There is a free standing gas cooker.
Chimney breasts and fireplaces	Visually inspected. No testing of the flues or fittings were carried out None
Internal decorations	Visually inspected Ceilings are mainly in an emulsion paint on a plain plasterboard backing. There is a light artex finish to the ceiling to the sunroom. Internal walls are painted on a lightly embossed paper. There is wallpaper in places. Internal joinery is mainly stained.

Cellars	Visually inspected where there was a safe and purpose built access None
Electricity	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on Mains electricity supply. The meter and fuse board are located in the cupboard to the hall. Electrical fittings are a mix of age.
Gas	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on There is a Calor gas supply to the cooker to the kitchen. The bottles and regulator are located to the rear.
Water, plumbing, bathroom fittings	Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation No tests whatsoever were carried out to the system or appliances Mains water supply. We did not locate the incoming rising main but note there is a stopcock below the sink in the kitchen. Plumbing supplies where viewed are in copper, wastes are in plastic. There is a cold water storage tank within the roof space but this appears redundant.
	Bathroom fittings comprise of a ceramic wc, ceramic wash hand basin and a low level proprietary shower. Surfaces within the bathroom are in a proprietary wet wall. There is an electric shower.
Heating and hot water	Accessible parts of the system were visually inspected apart from communal systems, which were not inspected No tests whatsoever were carried out to the system or appliances Central heating and hot water is provided by an external oil fired combi boiler. The boiler heats steel radiators throughout the property. There is a plastic oil storage tank adjacent to the right hand gable.
Drainage	Drainage covers etc were not lifted. Neither drains nor drainage systems were tested We believe drainage connects to the mains system.
Fire, smoke and burglar alarms	Visually inspected. No tests whatsoever were carried out to the system or appliances There are no fire or burglar alarms. There are smoke detectors in various places. Fire Safety Legislation effective from February 2022 requires a smoke alarm to be installed in the room most frequently used for living purposes and in every circulation space on each floor. A heat detection alarm must be installed in every kitchen area and all smoke and heat alarms must be ceiling mounted and interlinked. Where there is a carbon fuelled appliance e.g. central heating boiler, open fire, wood burning stove, etc, a carbon monoxide detector is also required. The purchaser(s) should appraise themselves of the requirements of this legislation and engage with appropriate accredited contractors to ensure compliance.

Only the subject flat and internal communal areas giving access to the flat were inspected If the roof space or underbuilding/basement is communal, reasonable and safe access is not always possible. If no inspection was possible, this will be stated. If no inspection was possible, the surveyor will assume that there are no defects that will have a material effect on the valuation The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance We have not carried out an inspection for Japanese Knotweed or other invasive plant species and unless otherwise stated for the purpose of this report we have assumes that there is no Japenese Knotweed or other invasive plant species within the boundaries of the proeprty or in neighbouring properties, the identification of Japenese Knotweed or other invasive plant species should be made by a Specialst Contractor. We were unable to view the subfloor space. We viewed the roof space from the ceiling hatch.

PART 1 - GENERAL

1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited Energy Company.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors require to amend the valuation in consequence of such information, they will issue an amended Report to the Seller. - any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisers of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

1.4 INTELLECTUAL PROPERTY

2.1 THE SERVICE

It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

2.2 THE INSPECTION





The energy efficiency rating of your home



About the recommended measures to improve your home's performance rating

1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

4 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

5 Replacement glazing units

Replacing existing double-glazed units with new high-performance units. Building regulations require that replacement glazing is to a standard no worse than previous; a building warrant is not required. Planning permission might be required for such work if a building is listed or within a conservation area so it is best to check with your local authority.

6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Low and zero carbon energy sources
