## 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc were not inspected or reported on.

Description	A mid-terrace ex local authority owned dwelling house.
Accommodation	<b>Ground floor:</b> hall, 2 bedrooms, box room, bathroom and a conservatory. <b>First floor:</b> landing, living room, kitchen and dining.
Gross internal floor area (m <sup>2</sup> )	92 sq m (to include the conservatory),
Neighbourhood and location	The property is set within the town of Fort William in an established local authority housing estate. All essential services, amenities and transport links are nearby.
Age	Built around 1964. The conservatory appears to be around 20 years of age.
Weather	Overcast with outbreaks of rain. The preceding weather was similar.
Chimney stacks	<i>Visually inspected with the aid of binoculars where appropriate</i> None.
Roofing including roof space	<i>Sloping roofs were visually inspected with the aid of binoculars where appropriate</i> <i>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3 m ladder externally</i> <i>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3 m ladder within the property</i> <i>If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so</i> The roof is of a mono pitch design covered in metal sheeting. The edges are in a metal trim. There is no roof space. The first floor ceiling follows the profile of the roof. Due to site conditions we were unable to view the roof surfaces.
Rainwater fittings	<i>Visually inspected with the aid of binoculars where appropriate</i> Upvc gutters. These discharge to plastic and cast iron gutters.
Main walls	<i>Visually inspected with the aid of binoculars where appropriate</i> <i>Foundations and concealed parts were not exposed or inspected</i> The external walls are in cavity brickwork construction. An outer insulated render system has been added. The original brickwork base course at ground level is exposed. Internal surfaces are mainly in a plaster on the hard.
Windows, external doors and joinery	<i>Internal and external doors were opened and closed where keys were available</i> <i>Random windows were opened and closed where possible</i> <i>Doors and windows were not forced open</i> Windows are in timber frame and casement with sealed double glazed panels. The front entrance door is in timber. Fascias/barge boards are in upvc. There is a canopy over the front door constructed in timber and supported on timber gallow brackets. The roof is slated.

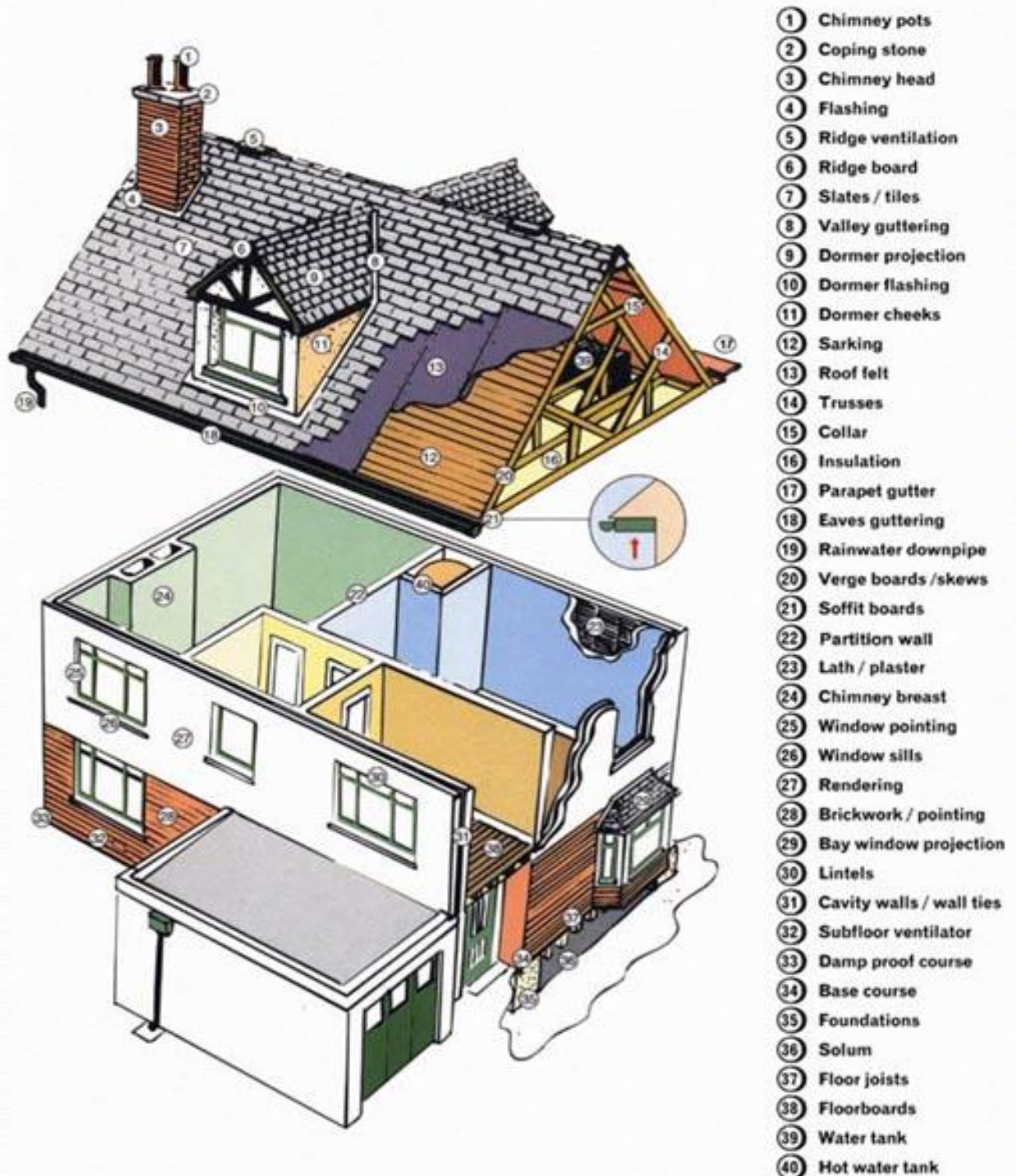
External decorations	<i>Visually inspected</i> The external door, windows and canopy are stained. The render to the front has a paint finish. The base course brickwork is painted.
Conservatories/porches	<i>Visually inspected</i> There is a conservatory to the rear constructed with double glazed upvc windows and screens and a French patio door. The roof is of a lean-to profile with polycarbonate sheeting. The floor is timber presumably on a concrete base.
Communal areas	<i>Circulation areas visually inspected</i> None
Garages and permanent outbuildings	<i>Visually inspected</i> There is a timber Wendy style house to the rear that is used as a garden store
Outside areas and boundaries	<i>Visually inspected</i> Ground to the front is small and surfaces are mainly covered in a concrete slab. There is a decent sized garden to the rear with concrete slab patios and grass surfaces. There is hedgerow to the extremities. Boundary fencing is generally in timber.
Ceilings	<i>Visually inspected from floor level</i> Plasterboard lined throughout.
Internal walls	<i>Visually inspected from floor level</i> <i>Using a moisture meter, walls were randomly tested for dampness where considered appropriate</i> Plastered masonry or timber framed with plasterboard linings.
Floors including sub floors	<i>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted</i> <i>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point</i> <i>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1 m between the underside of floor joists and the solum as determined from the access hatch</i> Floors are in suspended timber (boarded joists). These were covered and carpeted at the time of inspection. We were unable to view the sub floor space.
Internal joinery and kitchen fittings	<i>Built in cupboards were looked into but no stored items were moved</i> <i>Kitchen units were visually inspected excluding appliances</i> Facings and skirtings are in timber. Internal doors are in multi-glazed, four panel or flush panel. The stair is in original timber construction in two flights. Kitchen fittings comprise of a proprietary range of plastic vinyl faced base and wall units with a timber door, proprietary worktop, inset sink and integral electrical hob and oven housing.
Chimney breasts and fireplaces	<i>Visually inspected</i> <i>No testing of the flues or fittings were carried out</i> None.
Internal decorations	<i>Visually inspected</i> Ceilings and walls are in an emulsion paint finish on a plain plaster, woodchip or embossed paper. There is wallpaper in places. Internal joinery is painted or stained.
Cellars	<i>Visually inspected where there was a safe and purpose built access</i> None
Electricity	<i>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on</i> Mains electricity supply. The meter and fuse board are located within the airing cupboard to the ground floor.

Gas	<p><i>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on</i></p> <p>None</p>
Water, plumbing, bathroom fittings	<p><i>Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation</i></p> <p><i>No tests whatsoever were carried out to the system or appliances</i></p> <p>Mains water supply. There is a stopcock at low level within the bathroom. There is a plastic storage tank in the cupboard to the dining room. Plumbing supplies where viewed are in copper, wastes are in plastic. The water was switched off at the time of inspection.</p> <p>Bathroom fittings comprise of a ceramic wc, ceramic wash hand basin, a steel bath and a proprietary shower enclosure. There is an electric instantaneous shower. Surfaces within the bathroom are tiled.</p>
Heating and hot water	<p><i>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected</i></p> <p><i>No tests whatsoever were carried out to the system or appliances</i></p> <p>There is partial electric central heating from a combination of an original warm air boiler, storage and panel heaters.</p> <p>Hot water is heated and stored in a copper cylinder located in the ground floor. There are twin electric immersers.</p>
Drainage	<p><i>Drainage covers etc were not lifted</i></p> <p><i>Neither drains nor drainage systems were tested</i></p> <p>Drainage connects to the mains system.</p>
Fire, smoke and burglar alarms	<p><i>Visually inspected</i></p> <p><i>No tests whatsoever were carried out to the system or appliances</i></p> <p>There are no fire or burglar alarms. There are heat detectors in places.</p> <p>Fire Safety Legislation effective from February 2022 requires a smoke alarm to be installed in the room most frequently used for living purposes and in every circulation space on each floor. A heat detection alarm must be installed in every kitchen area and all smoke and heat alarms must be ceiling mounted and interlinked. Where there is a carbon fuelled appliance e.g. central heating boiler, open fire, wood burning stove, etc, a carbon monoxide detector is also required. The purchaser(s) should appraise themselves of the requirements of this legislation and engage with appropriate accredited contractors to ensure compliance.</p>

We were not able to view the subfloor space.</p> <p>We did not enter the shed.</p> <p>The property was fully furnished at the time of inspection. The extent of furniture had a limitation to the extent of our inspection.</p>

Notes	As mentioned above we were unable to view the roof surfaces. We would recommend an inspection is carried out by a competent roofer. There are a few slipped slates to the canopy at the front entrance door.  As advised above there is no roof space.

Notes	No evidence of any significant disrepair. Some seasonal maintenance is required.

Notes	As mentioned above there is damp to the ceiling and external wall in the kitchen and to the front wall at the entrance. This appears to be associated with the junction of the fascia board and top trim to the insulated render system. Some sealant has been applied at the entrance area recently. The paint finish and render at these locations and above the front living room window show signs of deterioration. A closer inspection is required.

Notes	The front door is swollen slightly and is difficult to open and close. There is some softening/rot to a glazing bead to a window in the front. Some window ironmongery would benefit from some easing. There is rot to the timber lining boards to the canopy.

Notes	The finish to the wall to the rear is heavily discoloured. There is some discolouration beginning to show to the paint finish to the render to the front.		

<b>Conservatories/porches</b>

Notes	The seals to several double glazed panels have failed causing misting between the glazed panels. These will require replacing. The door ironmongery is beginning to age.
<b>Communal areas</b>	
Repair category	Not applicable
Notes	
<b>Garages and permanent outbuildings</b>

Notes	The surfaces of the Wendy house are beginning to wear. There is rot to the handrail to the front.
<b>Outside areas and boundaries</b>

Notes	Some seasonal maintenance required. Slight wear to some tiles at the entrance steps. The timber fence to the rear is leaning.
<b>Ceilings</b>	
Repair category	3
Notes	There is damp and mould affecting part of the ceiling within the kitchen. The lining paper has dropped.
<b>Internal walls</b>	
Repair category	2
Notes	There is some wear to the plaster finish within the lobby due to lateral damp.

Notes	No evidence of any significant disrepair having regard to the limits of our inspection. As advised above the extent of household goods limited the extent of our inspection.

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.


## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 28 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 2.4 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 1.1 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.

## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Flat roof or sloping ceiling insulation

Insulating a flat roof or sloping ceiling will significantly reduce heat loss through the roof; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulation can be placed on top of the roof under the waterproof membrane and should particularly be considered when the waterproofing needs to be replaced. Further information about roof insulation and details of local contractors can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including [www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation](http://www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 3 Hot water cylinder insulation

Increasing the thickness of existing insulation by adding an 80 mm cylinder jacket around the hot water cylinder will help maintain the water at the required temperature; this will reduce the amount of energy used and lower fuel bills. The jacket should be fitted over the top of the existing foam insulation and over any thermostat clamped to the cylinder. Hot water pipes from the hot water cylinder should also be insulated, using pre-formed pipe insulation of up to 50 mm thickness, or to suit the space available, for as far as they can be accessed to reduce losses in summer. All these materials can be purchased from DIY stores and installed by a competent DIY enthusiast.

### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ## Low and zero carbon energy sources
