## 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc were not inspected or reported on.

Description	An end terraced dwelling house.
Accommodation	<b>Ground floor:</b> entrance hall, living room, kitchen and a dining/3 <sup>rd</sup> bedroom. <b>First floor:</b> landing, 2 bedrooms and a bathroom.
Gross internal floor area (m <sup>2</sup> )	94 sq m.
Neighbourhood and location	The property is set within the residential area of Inverlochty close to the centre of Fort William. Adjoining properties are of a similar type. All essential services, amenities and transport links are nearby.
Age	Built around 1940.
Weather	Overcast with outbreaks of rain. The preceding weather was similar.
Chimney stacks	<i>Visually inspected with the aid of binoculars where appropriate</i> There is a masonry constructed chimney stack at the party wall shared with the adjoining property. The stack is rendered and topped in a concrete cope with clay pots. There are lead flashings with the main roof.
Roofing including roof space	<i>Sloping roofs were visually inspected with the aid of binoculars where appropriate</i> <i>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3 m ladder externally</i> <i>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3 m ladder within the property</i> <i>If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so</i> The roof is pitched and covered in a natural slate. The ridge is in a replacement concrete interlocking tile. There is a Velux rooflight to the rear. The roof space is accessed via a ceiling hatch to the landing. The roof is of joiner make construction on a softwood sarking board. The party wall is in brickwork. There is insulation between and over the ceiling joists.
Rainwater fittings	<i>Visually inspected with the aid of binoculars where appropriate</i> Cast iron gutters. Downpipes are a mix of original cast iron and upvc.
Main walls	<i>Visually inspected with the aid of binoculars where appropriate</i> <i>Foundations and concealed parts were not exposed or inspected</i> The external walls are in cavity brickwork construction (2 walls with a narrow gap between). The outer wall is finished in a traditional wet dash render. Cavity wall insulation has been inserted. Internal surfaces are mainly in a plaster on the hard. There is later plasterboard in places.

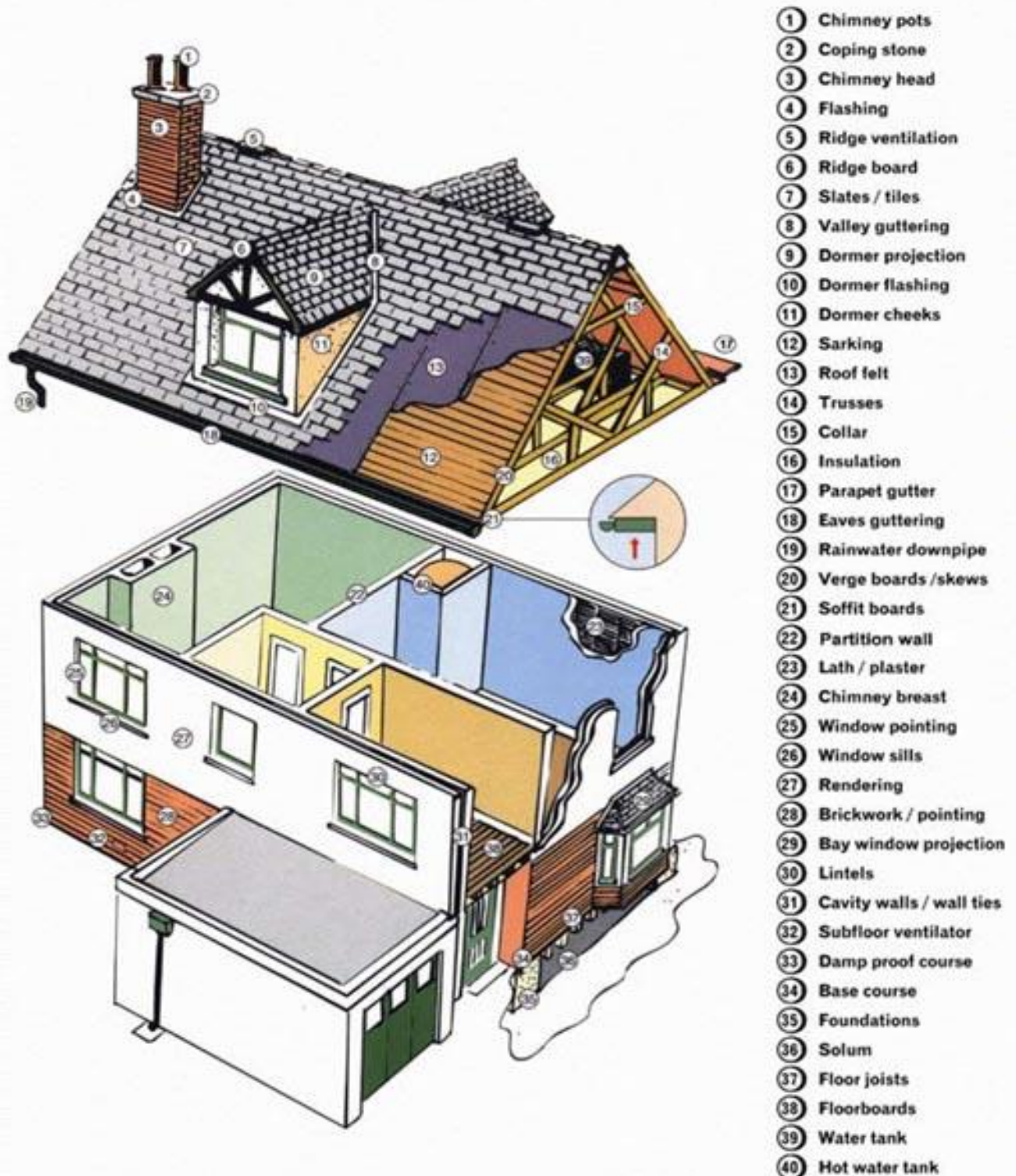
Windows, external doors and joinery	<p><i>Internal and external doors were opened and closed where keys were available</i></p> <p><i>Random windows were opened and closed where possible</i></p> <p><i>Doors and windows were not forced open</i></p> <p>Windows are in aluminium with sealed double glazed panels. The external doors are in timber. The eaves is of masonry construction.</p>
External decorations	<p><i>Visually inspected</i></p> <p>The timber doors are stained. The walls have a masonry paint finish.</p>
Conservatories/porches	<p><i>Visually inspected</i></p> <p>None</p>

These are mainly flat and covered in grass, bordered in hedgerow and mature bushes. Footpaths are in concrete slab. There is a large slab patio area to the rear. There is a timber garden shed to the rear.</p> <p>Boundaries are in timber, rylock and hedgerow.</p>
Ceilings	<p><i>Visually inspected from floor level</i></p> <p>Lath and plaster or plasterboard. The ceiling to the kitchen is in a timber lining board.</p>
Internal walls	<p><i>Visually inspected from floor level</i></p> <p><i>Using a moisture meter, walls were randomly tested for dampness where considered appropriate</i></p> <p>Plastered masonry or timber frame with plasterboard linings.</p>
Floors including sub floors	<p><i>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted</i></p> <p><i>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point</i></p> <p><i>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1 m between the underside of floor joists and the solum as determined from the access hatch</i></p> <p>The floors appear to be in suspended timber (boarded joists) throughout. The kitchen floor may be in concrete. Floors were fully covered and carpeted at the time of inspection. We were unable to view the sub floor space due to the lack of an accessible floor hatch.</p>
Internal joinery and kitchen fittings	<p><i>Built in cupboards were looked into but no stored items were moved</i></p> <p><i>Kitchen units were visually inspected excluding appliances</i></p> <p>Facings and skirtings are in timber. Internal doors are in replacement compressed panel. The stair is original and is in timber construction in one straight flight. The stair is carpeted and the underside is lined in plasterboard.</p> <p>Kitchen fittings comprise of a modern range of proprietary plastic vinyl faced base and wall units with a gloss finished door, solid timber worktop, inset sink and integral electrical appliances.</p>
Chimney breasts and fireplaces	<p><i>Visually inspected</i></p> <p><i>No testing of the flues or fittings were carried out</i></p> <p>The chimney breast is in a plaster on the hard. There is a fireplace opening to the living room with a slate front and hearth and timber surround. The chimney is capped at the pot.</p>
Internal decorations	<p><i>Visually inspected</i></p> <p>Ceilings and walls are in emulsion paint finish generally on a plain plaster or embossed and lining paper. There is feature wallpaper in places. Internal joinery is mainly painted.</p>
Cellars	<p><i>Visually inspected where there was a safe and purpose built access</i></p> <p>None</p>

Electricity	<p><i>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on</i></p> <p>Mains electricity supply. The meter and fuse boards are located at high level within the kitchen. Electrical fittings are a mix of age and type.</p>
Gas	<p><i>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on</i></p> <p>None</p>
Water, plumbing, bathroom fittings	<p><i>Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation</i></p> <p><i>No tests whatsoever were carried out to the system or appliances</i></p> <p>Mains water supply. There is a plastic cold water storage tank within the roof space. Plumbing supplies where viewed are in copper, wastes are in plastic and cast iron.</p> <p>Bathroom fittings are modern and comprise of a ceramic wc, ceramic wash hand basin, a plastic bath and a proprietary shower enclosure. There is an electric instantaneous shower. Surfaces within the bathroom are in a proprietary wet wall or tiled.</p>
Heating and hot water	<p><i>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected</i></p> <p><i>No tests whatsoever were carried out to the system or appliances</i></p> <p>Central heating is provided by an external wall mounted oil fired boiler which heats steel radiators throughout the property. There is a programmer located within the kitchen. Radiators have TRVs. The heating was on at the time of inspection. The oil storage tank is located to the rear.</p> <p>Hot water is heated and stored in a copper cylinder located to the first floor cupboard.</p>
Drainage	<p><i>Drainage covers etc were not lifted. Neither drains nor drainage systems were tested</i></p> <p>Drainage connects to the mains system.</p>
Fire, smoke and burglar alarms	<p><i>Visually inspected. No tests whatsoever were carried out to the system or appliances</i></p> <p>There are no fire or burglar alarms. There are smoke detectors in places.</p> <p>Fire Safety Legislation effective from February 2022 requires a smoke alarm to be installed in the room most frequently used for living purposes and in every circulation space on each floor. A heat detection alarm must be installed in every kitchen area and all smoke and heat alarms must be ceiling mounted and interlinked. Where there is a carbon fuelled appliance e.g. central heating boiler, open fire, wood burning stove, etc, a carbon monoxide detector is also required. The purchaser(s) should appraise themselves of the requirements of this legislation and engage with appropriate accredited contractors to ensure compliance.</p>

Only the subject flat and internal communal areas giving access to the flat were inspected</i></p> <p><i>If the roof space or underbuilding/basement is communal, reasonable and safe access is not always possible. If no inspection was possible, this will be stated. If no inspection was possible, the surveyor will assume that there are no defects that will have a material effect on the valuation</i></p> <p><i>The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance</i></p> <p><i>We have not carried out an inspection for Japanese Knotweed or other invasive plant species and unless otherwise stated for the purpose of this report we have assumed that there is no Japanese Knotweed or other invasive plant species within the boundaries of the property or in neighbouring properties. the identification of Japanese Knotweed or other invasive plant species should be made by a Specialist Contractor.</i></p> <p>As mentioned above, floors were fully covered and carpeted at the time inspection.</p> <p>We entered the roof space but we were unable to carry out a close inspection at the party wall / chimney stack due to the lack of appropriate crawl boards.</p>

Notes	<p>There are no significant repairs required to the slater work. A few individual slates are chipped or broken which is common for a property of this age.</p> <p>There is damp to the sarking board to the front. We suspect this is associated with the mortar tifting to the slates along the verges on the exposed elevation. This is a common defect for this time of year. No immediate action is required but the situation should be monitored. The brick party wall should be sealed to the underside of the sarking board to ensure a proper fire break with the adjoining property.</p>

Notes	No evidence of any significant disrepair. The cast iron rainwater goods appear original and may be nearing the end of their anticipated life cycle. There is one slightly discoloured joint to the front. At the time of inspection the rainwater goods were watertight.

Notes	<p>We recorded a couple of localised boss, (debonded) area of render typically on the rear elevation. In time, this will likely require to be repaired.</p> <p>There is some old hairline cracking to the render in places, but this is not considered to be significant.</p>

Notes	No evidence of any significant disrepair. The front door has swollen slightly and is stiff to open and close. The windows appear to be in excess of 30 years of age.

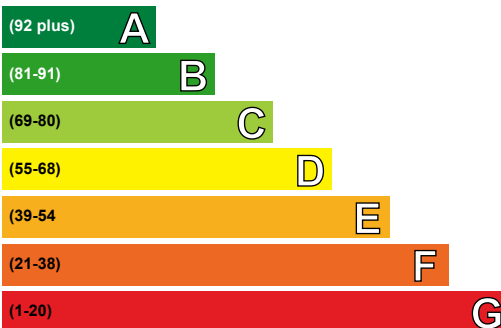

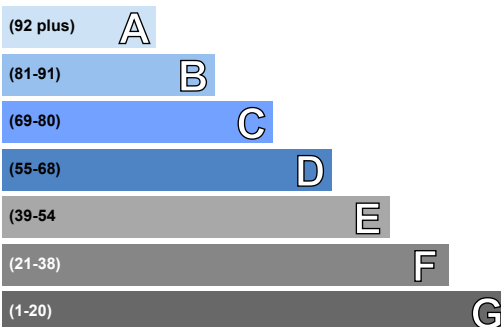

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.


## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 50 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 4.7 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 1.0 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.

## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including [www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation](http://www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 2 Cylinder thermostat

A hot water cylinder thermostat enables the boiler to switch off when the water in the cylinder reaches the required temperature; this minimises the amount of energy that is used and lowers fuel bills. The thermostat is a temperature sensor that sends a signal to the boiler when the required temperature is reached. To be fully effective it needs to be sited in the correct position and hard wired in place, so it should be installed by a competent plumber or heating engineer. Building regulations apply to this work, so it is best to check with your local authority building standards department whether a building warrant will be required.

### 3 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

### 4 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### 5 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
